SOC Technologies collects and uses information as part of its business operations to deliver services, respond to inquiries, provide customer support, and meet legal and contractual obligations. This includes personal details like your name, phone number, and email address, as well as professional information such as your job title, company, and role-related data, enabling us to respond effectively to your requests.

Where Do We Collect Personal Information?

Online collection: SOC Technologies collects voluntarily shared personal information online through multiple channels on our website including:

- **Quote Requests:** We collect information such as your company name, industry, first name, last name, email address and phone number to facilitate and respond to quote requests.
- **Contact Us:** For users seeking further information or assistance, we ask that you provide your company name, first and last name, and email address to respond to and fulfill your requests as well as provide, enhance and personalize our product, service, and technology offerings.
- Job Applications: We collect and use the personal information you submit through job applications and the Careers page to consider you for employment and facilitate the communities and communications on our site.

Offline collection: We collect personal information when you interact with us offline, including:

- **Conferences, trade shows, training, and similar events.** When you attend conferences, trade shows, or similar events, you may provide us with personal information, typically including personal details like your name and contact information, as well as professional information such as your job title and company name (e.g., from your business card).
- **Customer Service:** To ensure quality and support training, and to comply with legal obligations, we may monitor and record customer service calls. These recordings may contain personal information, including personal identifiers, professional details, and audio of the conversation.
- **Facility Visits:** For security and business purposes, we may collect video and audio footage of visitors to our facilities.
